- Listen intently to student feedback by embedding the student voice within the internal quality evaluation cycle, and to act upon student feedback as a catalyst for innovation and improvement.
- Offer students the opportunity to submit their music to our in-house record label *Point Blank Recordings* where they may be considered for recording and publishing contracts – not a requirement element of any program offering, but simply an additional added value.
- Offer students opportunities in the music industry, which are actively promoted through our blog, our Virtual Learning Environment (VLE), and other student-facing communications.
- Create strategic partnerships with external music industry organizations which ensure that our connection to the industry remains vital, relevant, and beneficial to students.
- Monitor and evaluate all courses and use the information gathered to improve our educational offerings and create new and innovative courses and learning pathways.

# GENERAL INFORMATION

## HISTORY AND OWNERSHIP

Point Blank Music School is a music and creative media training school founded in London in 1994 by musician and producer Robert Cowan. It offers a variety of courses in music production and sound engineering, DJ skills, singing, songwriting and radio broadcasting across its locations in London, Los Angeles, Ibiza, Hangzhou, and Mumbai. The Los Angeles location (organized as Point Blank Los Angeles, Inc. dba Point Blank Music School) first opened its doors in 2014.

## FACILITIES, EQUIPMENT, AND STUDIOS

Point Blank Music School offers training in a residential education format. All classes are held at 1215 Bates Avenue, Los Angeles, CA 90029, except in the case of occasional field trip visits offsite to recording studios or other places of interest within Los Angeles, for which students will either be provided transportation or given specific addresses for during the program.

Point Blank Music School is located at Mack Sennett Studios, a historic full-service film and photography studio, production sound stage, and private event space in the Silver Lake area which has served as a creative home to the Los Angeles cultural renaissance for more than 100 years. The school was initially set up in 2014 with one music production studio; a DJ studio was added in 2016, a second music production studio in 2017, and a vocal studio in 2019. The school's facilities and its equipment comply with all applicable federal, state, and local ordinances and regulations, including those requirements relating to fire safety, building and health. The locations include safe, well-lighted and ventilated classrooms, restrooms, offices, and a mezzanine break area which includes couches, tables, chairs, a water cooler, and a coffee machine.

Equipment in the classrooms and student areas is owned by Point Blank Music School and includes Apple iMac computers, Apple AirPlay televisions, projectors, whiteboards, monitor speakers and stands, a Midas Venice mixing console and mixers, guitars and basses, microphones, keyboard and tactile MIDI controllers, a digital piano, headphones, hard disk recorders, various DJ equipment, and more. There is a mezzanine break area for students which includes couches, tables and chairs.

**DJ Studio:** The DJ Studio is fully equipped with Pioneer DJ's latest equipment which currently includes the Pioneer CDJ2000 NX2S, DJM900 NXS2, PLX-1000 turntables, XDJ-1000, XDJ-700, HDJ2000MK2, Remix Station 1000 effects units, and more. Every student enrolled in our DJ courses benefits from an individual DJ workstation.

**Studio 1 and Studio 2:** Throughout the range of music production courses held in the two music production studios, each student enrolled has use and open access to Apple iMac workstations which each feature Ableton Live 10 Suite software, an Ableton Push tactile controller, a Native Instruments Komplete Kontrol S-49 keyboard controller, the Native Instruments Komplete 11 sound libraries, and a pair of AIAIAI TMA-Studio headphones. Each computer workstation is also loaded with the Output REV reverse sound library, one of the most creative sound design tools on the market. The studios are treated with GIK Acoustic Panels to create an optimal critical listening environment.

**Vocal Studio:** The Vocal Studio is equipped with 6 Shure microphones, a Behringer K3000FX PA/keyboard combo amplifier, a Casio Privia digital piano, an Output studio desk with Pioneer Built 6 monitor speakers, a solo Apple iMac workstation, a GIK Acoustic Panels Portable Isolation Booth, and more.

## APPROVALS

Point Blank Music School is a private institution approved to operate by the California Bureau for Private Postsecondary Education. # ADMISSIONS POLICIES AND PROCEDURES

## POLICY

Admission into any of the programs requires that the prospective student:

- Be 18 years of age or older (17 years of age is acceptable if the applicant has a high school diploma or the equivalent and can provide the written and signed consent of a parent or legal guardian);
- Have a high school diploma or the equivalent (Point Blank Music School will accept as a recognized equivalents of secondary education a GED, passing score on the California High School Proficiency Exam or another state's high school proficiency exam, a DD214 that indicates high school equivalency, a degree issued to the student that indicates the high school graduation, or documentation of enrollment in or completion of a bachelor's, master's, or doctoral degree at an accredited institution);
- Be provided the Catalog and the School Performance Fact Sheet for their program; and
- Sign an Enrollment Agreement.

## PROCEDURE

Admissions procedures include corresponding with an Admissions Officer to review goals, school policies and procedures, the School Performance Fact Sheet, catalog, and graduation requirements. Each prospective student must:

- Provide documentation of high school diploma or the equivalent;
- Review the School Performance Fact Sheet and Catalog; and
- Sign an Enrollment Agreement.

## COURSE SCHEDULING

Students are eligible to take up to three courses during a scheduled term. A term is defined as a period of 12 weeks; course weeks are defined at 10 weeks with optional 1-2-1 tutorials available in weeks 4, 8, and 11. Depending on the program of enrollment, any student taking less than the suggested number of courses per term will extend their scheduled program length for completion. In each course, students are required to attend four (4) scheduled contact hours per week in day, afternoon or evening sessions, for a total of forty (40) scheduled contact hours. For weekend sessions, students are required to attend six (6) scheduled contact hours on both a Saturday and Sunday for a total of twelve (12) contact hours for completion.

Point Blank Music School students are supported from the very beginning. Point Blank Music School instructors, staff administrators, and career services personnel work together to ensure the students are successful. Additional services to facilitate student success are included here:

- **Instructor-led lectures and project-based classwork:** Each course has a weekly class period lasting 4 hours. This period consists a blend of instructor-led lecture delivery, student exercises, and independent study. Instructors will provide extensive one-to-one support throughout the independent study. Students are also expected to access the course content on the Virtual Learning Environment each week (see details below), and the VLE will be used in class as a resource to support student learning.
- **Online Learning Platform:** Point Blank Music School has developed its own online learning platform, known as the Virtual Learning Environment (VLE) and accessible via [www.pointblankmusicschool.com](http://www.pointblankmusicschool.com). The VLE is our one-stop online hub for learning and assessment. Each course offered at Point Blank has its own mirrored area on the VLE where students can access weekly course notes, video content, and downloadable resources, as well as upload assignments and interact with other students in course forums. The VLE is a crucial part of the Point Blank experience, playing an integral role in each student's program.
- **Individual/Group Presentations and Demonstrations:** Some courses are assessed via a presentation or demonstration of the work developed throughout the program
- **Remote and On-Site Assistance:** The Music School Manager is always available during class time to assist students as required. The Forums on the VLE provide a communication channel for students to contact their instructor outside of class time.
- **Assessment Feedback:** Instructors will grade work and give developmental feedback based on the grading rubric for each assignment via the VLE.
- **1-2-1 Tutorials:** Students are able to book 1-2-1 sessions with their instructor in weeks 4 and 8, as well as in the week following course completion. These optional but highly-recommended student-directed sessions can be used to review musical projects or assignments closely, or for additional support and career development advice.

## COURSE DESCRIPTIONS

### **Music Production**

Prerequisite: None

Hours: 40

Description: This course aims to provide students with the primary theoretical understanding of MIDI and its integration into modern production practices and develops practical abilities in the application of MIDI sequencing, and audio editing. Students will be able to develop their understanding and confidence in the production and manipulation of MIDI based content for a wide range of popular music genres. These sessions will introduce key concepts and allow students to gain practical experience of using specialist music software. Students will be given a range of short practical tasks to work on in class with one-to-one support provided by the tutor. The course is designed to introduce specialist software and give students an overview of the range of features offered.

### **Music Composition**

Prerequisite: None

Hours: 40

Description: This course aims to develop the students' compositional ability using a combination of key musical understanding and the practical use of music creation software. Students will have the opportunity to investigate technical and stylistic conventions across a range of contemporary western popular music genres and to study key elements such as chord progressions, structure, harmony and melody, to develop their confidence and own abilities in composition. These sessions will explore musical composition techniques used in popular and contemporary music. The focus will be on deconstructing different works, exploring what their musical elements are and investigating what commonality these have across the boundaries of genre or instrumentation. Students will have experience of composing original musical elements and arranging these elements into complete compositions.

### **Essential DJ Skills**

Prerequisite: None

Hours: 40

Description: This course aims to provide students with an understanding of a range of fundamental DJ skills. They will develop a solid understanding of music theory concepts, as well as practical abilities in the application of these techniques. Students will be able to develop their understanding and confidence in the live performance of music using a range of popular dance music genres. These sessions will introduce key concepts and allow students to gain practical experience of using industry standard DJ hardware. Students will be given a wide range of short practical tasks to work on in class with one-to-one support provided by the instructor.

### **Creative DJ Skills**

Prerequisite: *Essential DJ Skills (or the equivalent)*

Hours: 40

Description: This course aims to provide students with an understanding of a range of creative DJ skills and techniques. They will develop a solid understanding of vocal structures, harmony and common audio effects, as well as practical abilities in the application of these techniques in a DJ context. Students will be able to develop their understanding and confidence in the live performance of music using a range of creative techniques including looping, cue points and basic Turntablism principles. They will also develop an understanding of the recording and editing process using a professional DAW. These sessions will introduce key creative concepts and allow students to gain practical experience of using industry standard DJ hardware to implement these in a live scenario. They will also serve to give students experience of using a DAW platform to create mixes suitable for broadcast. Students will be given a wide range of short practical tasks to work on in class with one-to-one support provided by the lecturer. The course is designed to introduce specialist hardware and software and give students a basic overview of the range of features offered.

### **Sound Design**

Prerequisite: None

Hours: 40

Description: This course aims to provide a fundamental understanding of different types of synthesis as well as exploring the capabilities of software instruments. Students will develop a practical awareness of different synthesis techniques using modular synthesis software and will build their own software instruments with a range of sounds to use in a creative context. These sessions will explore different types of synthesis focusing

on the practical application and exploring the methodology behind the mechanics. There will be a mixture of tutor-led demonstrations and opportunities for students to get practical experience of synthesizing sounds using a variety of software and hardware synthesizers.

### **Art of Mixing**

Prerequisite: *Music Production (or equivalent skills)* Hours: 40

Description: This course aims to explore the process, equipment, considerations and techniques involved in creating professional stereo mixes. Students will develop their critical listening skills as well as solid technical and creative skills essential to mixing commercially based music. Students will be developing their critical listening through instructor-led demonstration and associated practical individual tasks. The sessions will be practical and active with the students encouraged to listen to music on a range of speakers and headphones, working to train their ears to listen to recorded sound from a technical, rather than creative, point of view.

### **Creative Production & Remix**

Prerequisite: None Hours: 40

Description: This course aims to explore the Creative Production & Remix processes involved in the worlds of media composition, remixing and live performance, using Ableton Live. Students will learn a range of specialist techniques which will help them further develop their skills as a musicians, composers and performers, and widen the scope for work opportunities within the music industry.

### **Production Analysis**

Prerequisite: None Hours: 40

Description: This course aims to encourage and develop the students' research and analytical skills in relation to music production and its wider cultural context. By exploring a range of contemporary genres and tracing their technological, artistic and socio-cultural roots back through the popular and electronic music of the 20<sup>th</sup> century, students will build an informed awareness of key movements and developments in music production and pop culture. Study of significant or landmark recordings will inform the students' own productions as they are encouraged to emulate specific techniques in their own work. This course will explore landmark production techniques utilizing classic pieces of hardware and software equivalents. Students will get opportunities to experiment and practice with classic synthesizers and samplers, linking the features of these to modern day software equivalents.

### **Music Business**

Prerequisite: None Hours: 40

Description: The course aims to explore the opportunities in the music business made possible in the new digital age, and focuses on management skills, artist representation, as well as a variety of other roles in the music industry. Students will gain a solid grasp of how the music industry operates, what a record company's purpose is, record deals, publishing and contracts, and how the financial side of the industry works.

### **Audio Mastering**

Prerequisite: *Music Production (or equivalent skills)* Hours: 40

Description: This course aims to study professional practices used throughout the audio mastering process. Students will have the opportunity to gain a strong knowledge of digital audio to maintain the highest sound quality throughout the various stages of the production process. Students will be able to perfect their critical listening skills and processing techniques to produce professional pre-masters for a range of formats suitable for replication and distribution.

### **Electronic Music Performance**

Prerequisite: None Hours: 40

Description: This course aims to introduce students to a different approach to sequencing and explore the creative possibilities for music production and live performance. Students will also explore the integration of hardware controllers to manipulate sound and musical structure through improvisation and will develop a spontaneous and creative approach which can be applied to composition, production and performance. The course will not just focus on the creative aspects of live performance but will also look at the professional and technical considerations in producing and editing materials for live performance.



### **Composing for Film & TV**

Prerequisite: None

Hours: 40

Description: This course aims to provide students with the relevant skills to be able to produce music and sound design for a range of broadcast media such as TV and film. Specific case studies will be analyzed to develop critical listening and develop an understanding of the function of music and sound in modern as well as traditional media. Students will be expected to work to a brief for a variety of different scenarios. This course builds on the compositional skills acquired and developed during earlier courses. The course will be framed in a vocational context with students asked to respond creatively to briefs, interpreting author intentions into a tangible musical form to fit with given visual stimuli. Initially, key concepts will be delivered regarding terminology specific to music for media and creative practice in sound to picture. Students will need to understand how the file format requirements differ when working within this environment.

### **Production Portfolio**

Prerequisite: None

Hours: 40

Description: This course is designed to give students an opportunity to plan, research, implement and evaluate a substantive project within their area of interest in music technology. The emphasis is to facilitate students in the creation of a specialist portfolio of work, grounded in academic research and principles, that can be used to support employment within their chosen field. Students will work largely autonomously with tutorial support from an expert in their field of study.

### **Native Instruments Maschine**

Prerequisite: None

Hours: 40

Description: This course aims to provide students with techniques for approaching electronic music production in an intuitive, hands-on way through mastery of Native Instrument's Maschine production system. Through demonstration, study and practice they will learn the functionality of Maschine as well as gain an understanding of how best to incorporate it into their individual workflows. Students are taught that by integrating performance concepts into production they can improve workflow and achieve creative results. The course focuses on in-class, practical exercises giving students opportunities to collaborate by producing tracks together, creating and rehearsing performances and providing opportunities for peer evaluation. Additionally, the assessments offer students the experience of working to a brief and producing work under time pressure.

### **Singing**

Prerequisite: None

Hours: 40

Description: This course is designed to develop strong foundations for solo vocal performance, equip students with a basic range of effective singing techniques and skills, and instill confidence and powerful presence both in the studio and in live performance. Students will learn a range of specialist techniques which will help them further develop their skills as as singers, performers, and well-rounded musicians, widening the scope for work opportunities within the music industry.

### **Advanced Singing**

Prerequisite: Singing

Hours: 40

Description: This course is designed to develop advanced techniques for vocal performance, recording, and vocal harmony arrangement in various genres. The skills and theory learned as part of the course will be transferable throughout many of the Point Blank courses. Students will learn a range of specialist techniques which will help them further develop their skills as as singers, performers, recording artists, and well-rounded musicians, widening the scope for work opportunities within the music industry.

# ACADEMIC POLICIES

## GRADING SYSTEM

Final course grades are based on demonstration of meeting the learning outcomes as stated on each course syllabus:

Grade	Grade Percentages
P – Pass	70%-100%
F – Fail	69% or below
R – Repeated	Based on grade.
W – Withdrawal	0%

**P – Pass:** Any course with a “P” grade is identified as successful completion to graduate.

**F – Fail:** Any course with a “F” grade must be repeated and passed to graduate.

**R – Repeated:** When a course is repeated to improve a previously earned grade, the first grade is replaced with a new grade upon completion of the repeat. Any course that has a grade of “F” (Fail) or “W” (Withdrawal) is required to be repeated. Any course with an “R” grade is not calculated into the grade point average.

**T – Transfer Credit:** Transfer of credit, a “T” is provided when a student has successfully completed a course within another Point Blank Music School program that applies to a different program of enrollment.

**W – Withdrawal:** Withdrawal, a “W” grade is provided when a student leaves the course or is withdrawn from the school prior to the scheduled completion of a course. Any course with a “W” grade is not calculated into the grade point average.

## SATISFACTORY ACADEMIC PROGRESS

Point Blank Music School standards of satisfactory academic progress (SAP) apply to all students. Students must continually maintain satisfactory academic progress in order to continue their education. To maintain satisfactory academic progress students are monitored through attendance, assignments, portfolios, compositions, assessments, performances, essays, group discussions, individual and group presentations and demonstrations and research tasks as specified in the evaluation methods of each individual course. Students must achieve a passing grade in each course attempted as a pre-requisite to maintain satisfactory academic progress. Course evaluation methods are all graded using the following grading scale:

<u>ACCURACY</u>	<u>GRADE</u>
70% - 100%	Pass
0% - 69%	Fail

If a student fails to meet the satisfactory academic progress, the Chief Academic Officer will place the student on academic probation. If a student remains on academic probation at the end of the next grading period, the student will be subject to termination for lack of progress. If a second probation period is granted and not passed the student will be terminated from the program.

## **APPEAL / PROBATION / DISMISSAL**

A student who is withdrawn can appeal within five (5) business days of notification of their change in status, and request to be placed on secondary probation with an academic plan. In order for an appeal to be considered, the student must provide the Chief Academic Officer with a letter that includes:

- information about the circumstances which prevented the student from attaining SAP;
- why the student failed to make SAP; and
- what has changed in order for the student to be successful.

The Chief Academic Officer will review only appeals based on the following:

- severe illness, medical condition, or injury
- death of an immediate family member
- traumatic life-altering event, or
- military deployment/call to active duty

Appeals must state the basis of the appeal and include written documentation of the circumstances. The Chief Academic Officer will then determine whether the student is eligible for an academic plan and can regain SAP within the maximum timeframe. The student will be notified in writing, within five (5) business days, of the final decision. There are no additional appeals processes.

If probation is granted and conditions within the academic plan are met, probation will continue until the student meets the SAP requirements or fails to meet the probation conditions or reaches the maximum timeframe to complete the course and is withdrawn. If the student is unsuccessful with the appeal, the student will be administratively withdrawn from the program. A student will only be allowed one appeal of probation status for the length of the program.

## **WITHDRAWAL**

A student may be deemed to have withdrawn from a program when any of the following occurs:

- The student notifies the institution of the student's withdrawal or as of the date of the student's withdrawal, whichever is later.
- The institution terminates the student's enrollment for failure to maintain satisfactory academic progress; failure to abide by the rules and regulations of the institution; absences in excess of maximum set forth by the institution; and/or failure to meet financial obligations to the School.

## **ATTENDANCE**

Point Blank Music School considers attendance an essential component of the program. Students enrolled at the institution make a commitment to participate fully in their education by attending classes and accounting for any absences.

It is the student's responsibilities to address the issues related to his/her absenteeism, whatever the circumstances, and are responsible for obtaining material covered during an absence. A student has an option to determine with the instructor, whether and under what conditions make-up work will be permitted.

Point Blank Music School does not offer excused absences.

Point Blank Music School requires regular classroom attendance by all students. **A minimum attendance rated of 65% based on the entire length of a program is mandatory.** Students must notify the school before being absent so that arrangements can be made to minimize work missed. If a student's attendance falls below the minimum 65% requirement, the student will be placed on attendance probation. Any student absent for six (6) consecutive weeks will be administratively withdrawn from the program.

### **LEAVE OF ABSENCE POLICY**

Requests for leave of absence may be granted for emergency medical reasons or personal emergencies only. The student must submit a written request to the Music School Manager for approval. Supporting documentation and evidence is required. A student may be granted a leave of absence not to exceed a total of one term or 11 weeks. If a student does not return on the documented return date, he/she will be withdrawn from the program.

### **RE-ENTRY**

Students who have been withdrawn from a program may request re-entry into the program and are required to meet with the Music School Manager. A re-entry request will be considered when the reasons which caused the withdrawal have been rectified. Re-entering students will be charged at the current published tuition rates for the portion of the program to be completed as stated on the Enrollment Agreement.

### **GRADUATION REQUIREMENTS**

The following requirements must be met for a student to graduate from any program at Point Blank Music School:

1. Successful completion of all program courses and hours;
2. A minimum cumulative grade point average of 70%; and
3. Has cleared all financial obligations.

# RULES AND REGULATIONS

## *INTRODUCTION*

Point Blank seeks to provide a safe, secure environment which is conducive to work and study for all students and staff. It may therefore be necessary to discipline, suspend, or exclude students whose behavior compromises this. It is not the intention of this procedure to provide an exhaustive list of matters which might lead to disciplinary action. For the purposes of this procedure, misconduct will be taken to have occurred if a student commits a breach of these rules or any other reasonable rules in force from time to time, engages in any activity which is likely to disrupt or otherwise adversely affect the work or reputation of the Institute or any of its staff or students or commits a criminal offense. The procedures outlined herein are intended to provide a clearly formulated and impartial process for dealing with problems of student discipline or behavior within a reasonable timescale.

## *DEFINITION OF MISCONDUCT*

- Misconduct may include, but is not limited to the following:
- Deliberate disruption of the academic, administrative, social or other activities of Point Blank.
- Violent, indecent, disorderly, threatening, defamatory or offensive behavior or language whilst on Point Blank premises, or engaged in any activity related to Point Blank (on or off-site).
- Failure to follow the reasonable instructions of a member of staff.
- Harassing any student, tutor, member of staff or any contractor or visitor to Point Blank whether in person, in writing or otherwise.
- Any deliberate damage to Point Blank's premises, equipment, books or furnishings or to the property of others, or equivalent damage caused by gross negligence
- Instances of racial or sexual harassment including behavior or the use of language which is offensive to any minority groups.
- Theft of property, graffiti, or arson
- Intoxication on campus, or activity related to the use, possession, or supply of any controlled substance drug.
- Willful and unnecessary activation of the fire alarm.
- Action which causes or is likely to cause injury or impair safety on Point Blank premises.

## *MINOR MISCONDUCT PROCEDURE*

Where a minor case of misconduct is identified by any staff member, they should warn the student verbally that the behavior is not acceptable and notify them that the incident will be reported to the Education Team. Where this staff witness knows or suspects that this is a repeat incident, or where the incident is relatively serious, he/she should explain to the student that this may lead to more formal action. Following notification, the Education Team will make a note of the incident and, taking into account its seriousness and any past history of misconduct, will determine whether it is appropriate to interview the student about the matter or to take no further action. Any student who is requested to attend an interview will be entitled to be accompanied by a friend or colleague. As a result of any interview, the assigned member of the Education Team will either:

- take no further action; or,
- issue a formal warning.

Any formal warning will only be issued after the circumstances have been investigated and the student has been offered an opportunity to discuss the matter and present their case.

## *MAJOR MISCONDUCT PROCEDURE*

Where a case of major misconduct is identified or where minor misconduct has occurred repeatedly or so frequently as to cause a major problem, a preliminary investigative interview with the alleged perpetrator will be conducted by a member of the Academic Board, whenever possible, in order to:

- determine their identity
- establish and record their reactions to the allegations
- listen to any explanation they may have
- assess whether the case remains plausible enough (taking into account other reports) to proceed with suspension or expulsion

Where applicable, a Disciplinary Panel, consisting of at least 2 Senior Staff, will then be convened. One of the two staff will act as Chair. The student has the right to be accompanied by a (non-legal) representative, and if the student is under 18 their parents or guardians will be informed of, and may attend, the hearing where appropriate.

The Disciplinary Panel will consider all the evidence about the case gathered as well as the student's response with a view to deciding whether the allegation is substantiated.

In the event of the case being substantiated, the Disciplinary Panel will impose or recommend a verdict. If exclusion, either time limited or permanent, is thought appropriate this will be a recommendation to the Head of Education. All lesser penalties will be imposed directly. The panel may also impose any other measures/conditions which it feels will prevent a re-occurrence or assist the situation (e.g. requiring the student to undergo regular counseling or personal tutoring, maintain good attendance, move class groups, apologize to affected students/staff).

Among the penalties that the Disciplinary Panel may impose are:

- the attachment of conditions to the student's continuation of study
- the issue of a verbal, written or final written warning
- the issue of a recommendation for suspension or expulsion

The Disciplinary Panel is also empowered to require the student to pay compensation in respect of any loss or damage to Point Blank resource arising from the actions of the student.

The Chair will notify the student in writing of both the verdict and any penalty imposed within 5 working days of the hearing.

Except at the discretion of the Disciplinary Panel the proceedings of the Disciplinary Hearing shall remain confidential.

Please note that this is a guide only and serious cases of misconduct may incur more serious action to that indicated.

## ACCUMULATION OF WARNING POINTS

Where a student's behavior is considered under the Student Disciplinary Procedure, warning points may be recorded according to the seriousness and nature of the behavior. Offenses, for the purpose of warnings, fall into different levels of seriousness classified on a four point scale: minor – serious – grave – suspension/expulsion. Where a student has accumulated 4 or more warning points within any period of 24 months, the period to start from the date of the first confirmed warning, then the Head of Education will consider the suspension or expulsion of the student. Before making a decision to suspend or expel, the Head of Education will consider the detail of the individual offenses which have led to the accumulation of four or more warning points and shall hear representations from the student.

## GRIEVANCE PROCEDURE

If you should ever have any complaint(s), please speak to any member of staff and we will do our best to resolve the matter. If you are unhappy with the outcome, please put your complaint in writing

to the Chief Academic Officer at Point Blank Music School/Mack Sennett Studios, 1215 Bates Avenue, Los Angeles, CA 90029.

1. **COMPLAINTS PROCEDURE:** If you have a suggestion or a complaint about any aspect, please raise it with the person concerned in the first instance. If you are not satisfied with the outcome you can progress the matter through a first stage, informal, and second stage and third stage, formal, procedures step by step up the management structure of Point Blank Music School.

2. **FIRST STAGE (INFORMAL):** Wherever possible, Point Blank seeks to resolve complaints informally, with complaints procedures operating, in the first instance, at the level at which the matter arose. If an informal solution cannot be found, then the student can raise a second stage, formal complaint addressed to the Music School Manager. This should be submitted in writing.

3. **SECOND STAGE (FORMAL):** If an informal solution cannot be found, then the student can raise a second stage, formal complaint addressed to the Music School Manager. This should be submitted in writing.

4. **THIRD STAGE (FORMAL):** If the matter cannot be resolved at this formal second stage, then the student may request, in writing, a third stage formal investigation to be conducted by the Chief Academic Officer.

# CANCELLATION, WITHDRAWAL AND REFUND POLICY

## STUDENT'S RIGHT TO CANCEL

You have the right to cancel your Enrollment Agreement for a program of instruction, without any penalty or obligations, through attendance at the first class session or the seventh calendar day after enrollment, whichever is later. If you elect to cancel your Enrollment Agreement, Point Blank Music School will refund you any money you paid, less registration and/or administrative cancellation fees not to exceed \$250.00 in total, and less any reasonable deduction(s) for the cost of any software activation code(s) redeemed or textbooks, supplies, or equipment not returned in good condition. Your refund will be paid or credited within 45 days after the Music School Manager has received your notice of cancellation. If any portion of your tuition was paid by a lender or third party, the corresponding portion of the refund shall be sent to the lender or third party.

To cancel your Enrollment Agreement, you must provide the Music School Manager with a written notice of cancellation. This must be done by mail or by hand delivery to 1215 Bates Avenue, Los Angeles, CA 90029. The written notice of cancellation, if sent by mail, is effective when properly addressed, affixed with proper postage, deposited in the mail, postmarked, and received by Point Blank Music School. The written notice of cancellation need not take any particular form; however expressed, it is effective if it clearly states that you no longer wish to be bound by the Enrollment Agreement. You may use Point Blank Music School's approved Program Cancellation Form if you wish; this form may be obtained from the Music School Manager.

## WITHDRAWAL FROM A PROGRAM

After the end of the cancellation period described above, you also have the right to withdraw from your program at any time, and, if you have completed 60 percent or less of the scheduled hours in the current payment period of your program, you have the right to receive a pro rata refund. The refund amount owed to you shall equal the daily charge for the program (total institutional charge, minus non-refundable fees, divided by the number of hours in the program), multiplied by the number of hours scheduled to attend prior to notification of withdrawal. The refund will be paid or credited within 45 days after the Music School Manager has received your notice of withdrawal, and will be less registration and/or administrative withdrawal fees not to exceed \$250.00 in total, and less any reasonable deduction(s) for the cost of any software activation code(s) redeemed or textbooks, supplies, or equipment not returned in good condition. If you have completed more than 60 percent of the period of attendance for which you were charged, the tuition is considered earned, and no refund will be issued. If any portion of your tuition was paid by a lender or third party, the corresponding portion of the refund shall be sent to the lender or third party.

You shall be deemed to have withdrawn from your program when any of the following occurs:

- You notify the Music School Manager of your withdrawal, or of a future date upon which you will withdraw, whichever is later.
- You fail to attend class for six (6) consecutive weeks.
- You fail to return from a leave of absence.
- Point Blank Music School terminates your enrollment for failure to maintain satisfactory progress, failure to abide by institutional rules or policies, and/or failure to meet your financial obligations to the institution.

To withdraw from your program, you must provide the Music School Manager with a written notice of withdrawal. This must be done by mail or by hand delivery to 1215 Bates Avenue, Los Angeles, CA 90029. The written notice of withdrawal, if sent by mail, is effective when properly addressed, affixed with proper postage, deposited in the mail, postmarked, and received by Point Blank Music School. The written notice of withdrawal need not take any particular form; however expressed, it is effective if it clearly states that you wish to withdraw from your program at Point Blank Music School. You may use Point Blank Music School's approved Program Cancellation/Withdrawal Form if you wish; this form may be obtained from the Music School Manager.

For the purpose of determining the amount of your refund, if you notify the Music School Manager of your withdrawal, the date of your withdrawal shall be deemed to be the date upon which Point Blank Music School received your notification of withdrawal, or the future date your notification of withdrawal identifies as your withdrawal date, whichever is later. If you fail to notify Point Blank Music School of your withdrawal but you stop attending all classes, the date of your withdrawal shall be deemed to be the final day of six (6) consecutive weeks of recorded absence, or the date you are administratively withdrawn for failure to meet your financial obligations to the institution, whichever is earlier.

## **TUITION & FEES PAYMENT METHODS**

Point Blank Music School accepts payment of tuition and fees via credit card, PayPal, Worldpay, or direct debit from a bank account. Visa and MasterCard are the only accepted credit cards. **No other forms of payment are accepted. No cash payments will be accepted, under any circumstances.**

Upon enrollment, a student has the option to either pay the total tuition and fees upfront as a lump sum immediately, or enroll in a termly or monthly installment payment plan, each outlined below.

Students who have not paid both a registration fee and an acceptable initial payment of tuition prior to the first day of instruction in their program will not be allowed to attend classes.

## **TERMLY & MONTHLY INSTALLMENT PLANS FOR TUITION PAYMENT**

Termly and monthly installment payment plans are available to all students. Installment plans must be selected during the online registration process or arranged with an Admissions Officer prior to the first day of instruction according to the following guidelines. All students wishing to pay by termly or monthly installments must provide either:

- 1) valid credit or debit card details, from which Point Blank will deduct the term tuition and fees as and when they become due; or,
- 2) bank account details from which a termly direct debit of an agreed amount is set up to pay into Point Blank's designated account with the first payment due before the first day of the course and thereafter at least two weeks before the first day of each subsequent term until all due payments are completed (and please note that Point Blank requires written evidence of all such direct debits before the first payment), or:

NOTE: If a student registers themselves for a program through [www.pointblankmusicschool.com](http://www.pointblankmusicschool.com) and pays the registration fee via Worldpay, termly or monthly installment plans paid via credit or debit cards can be set up automatically.

Termly installment plans do not incur any additional fee. A 5% convenience fee is added to the cost of tuition for students electing to pay their tuition on a monthly installment plan; this fee is included in the price quoted for monthly installment plans on each program overview page on the Point Blank Music School website.

Installment payments must be made in the form of Visa, MasterCard, Worldpay, or PayPal. In the event that a student fails to pay using one of these methods for any reason (including, without limitation, a card being or becoming invalid) there will be an additional late fee charge of \$25.00 per transaction. For a full list of fees and details, please refer to the Enrollment Agreement.

## **LATE PAYMENTS**

Every student must pay the required tuition and fees, as applicable, in accordance with the payment schedule and terms described above and identified on the Enrollment Agreement, or else have an approved request for other arrangements made with the Admissions Officer prior to a payment due date. If any payment is not received by the due date, Point Blank reserves the right to withdraw the student from the relevant program(s) outright, or suspend the student's right to attend until the appropriate payment(s) is/are made. Repeated late payments may result in a student's withdrawal.

## **STUDENT TUITION RECOVERY FUND**

The State of California established the Student Tuition Recovery Fund (STRF) to relieve or mitigate economic loss suffered by a student in an educational program at a qualifying institution, who is or was a California resident while enrolled, or was enrolled in a residency program, if the student enrolled in the institution, prepaid tuition, and suffered an economic loss. Unless relieved of the obligation to do so, you must pay the state-imposed assessment for the STRF, or it must be paid on your behalf, if you are a student in an educational program, who is a California resident, or are enrolled in a residency program, and prepay all or part of your tuition.

It is important that you keep copies of your enrollment agreement, financial aid documents, receipts, or any other information that documents the amount paid to the school. Questions regarding the STRF may be directed to the Bureau for Private Postsecondary Education, 2535 Capitol Oaks Drive, Suite 400, Sacramento, CA 95833, (916) 431-6959 or (888) 370-7589.

To be eligible for STRF, you must be a California resident or enrolled in a residency program, prepaid tuition, paid or deemed to have paid the STRF assessment, and suffered an economic loss as a result of any of the following:

1. The institution, a location of the institution, or an educational program offered by the institution was closed or discontinued, and you did not choose to participate in a teach-out plan approved by the Bureau or did not complete a chosen teach-out plan approved by the Bureau.
2. You were enrolled at an institution or a location of the institution within the 120 day period before the closure of the institution or location of the institution, or were enrolled in an educational program within the 120 day period before the program was discontinued.
3. You were enrolled at an institution or a location of the institution more than 120 days before the closure of the institution or location of the institution, in an educational program offered by the institution as to which the Bureau determined there was a significant decline in the quality or value of the program more than 120 days before closure.
4. The institution has been ordered to pay a refund by the Bureau but has failed to do so.
5. The institution has failed to pay or reimburse loan proceeds under a federal student loan program as required by law, or has failed to pay or reimburse proceeds received by the institution in excess of tuition and other costs.
6. You have been awarded restitution, a refund, or other monetary award by an arbitrator or court, based on a violation of this chapter by an institution or representative of an institution, but have been unable to collect the award from the institution.
7. You sought legal counsel that resulted in the cancellation of one or more of your student loans and have an invoice for services rendered and evidence of the cancellation of the student loan or loans.

To qualify for STRF reimbursement, the application must be received within four (4) years from the date of the action or event that made the student eligible for recovery from STRF.

A student whose loan is revived by a loan holder or debt collector after a period of noncollection may, at any time, file a written application for recovery from STRF for the debt that would have otherwise been eligible for recovery. If it has been more than four (4) years since the action or event that made the student eligible, the student must have filed a written application for recovery within the original four (4) year period, unless the period has been extended by another act of law.

However, no claim can be paid to any student without a social security number or a taxpayer identification number.
